

Electric Bicycle Rental Terms and Conditions

Kutná Hora Town Information Centre, Kollárova 589, 284 01 Kutná Hora, IČO 00236195, DIČ CZ00236195 (hereafter the "Information Centre") is permitted to rent electric bicycles (hereafter "e-bikes") in its exclusive ownership to its customers (hereafter "Customers"). E-bikes are available for rent by Customers on a long or short term basis. A rental record is issued and signed by both the Information Centre and the Customer (hereafter the "Record").

Customers are not permitted to cede the rented items to a third person (except where an e-bike is rented by parent or guardian on behalf of their child aged 15 years and above). Customers are not permitted to sell the e-bike to a third person, nor technically adjust the e-bike.

When renting e-bike accessories, such as helmets, or other accessories, the accessories are considered, for the purpose of rental terms and conditions, the same as an e-bike.

Customers are required to present a valid form of identification (e.g. a driver's licence or a passport).

E-bikes can only be **rented by persons aged 18 years and above**.

A deposit is required of CZK 5 000 per e-bike.

Deposits will be refunded to Customers upon return of the rented e-bikes in due time and in good order. If an e-bike is not returned in due time and in good order, the Information Centre may use the deposit to pay any outstanding balance arisen from the breach of the rental conditions. The deposit may also be used as partial payment for failure to return an e-bike or e-bike accessories. **If an e-bike or e-bike accessories is not returned for any reason, the Customer agrees to pay to the Information Centre the following compensation:** CZK 35.000,- per e-bike, CZK 900,- per helmet, CZK 150,- per lock. If the rented equipment is damaged, Customers are required to declare this to the Information Centre staff when returning the e-bike, and will be required to cover the cost of any repairs.

Riding a rented e-bike is at the Customer's risk and the Information Centre is not liable for any damages to property or injury to persons including to the Customer caused by the e-bike, while it is being rented. Liability for any such damages or injury falls to the Customer.

In the event of a defect or breakage of the e-bike, it is the Customer's responsibility to transport him/herself and the e-bike to the place of rental - the Information Centre is not obliged to arrange any transportation.

While renting an e-bike, Customers are required to make sure the e-bike is secured against theft and damage. If an e-bike is damaged by a third party, lost or **stolen**, Customers are obliged to inform the Information Centre and the **Police**.

Information Centre recommends the use of safety helmets and other accessories, all of which are available for rent without extra cost.

Before using an e-bike, the Customer is required to inspect it thoroughly and report any obvious defects. Subsequent complaints will not be accepted. By signing the Record, the Customer confirms that he/she is acquainted with the technical condition of the e-bike.

The rented e-bikes are considered sporting equipment and comply with the road traffic regulations.

By signing the Record, the Customer confirms that he/she is acquainted with the Electric Bicycle rental terms and conditions and that he/she accepts them.
