

## Bicycle rental terms and conditions

Kutná Hora Town Information Centre, Palackého nám. 377, 284 01 Kutná Hora, IČO 00236195, DIČ CZ00236195 (hereafter the "Information Centre") is permitted to rent bicycles in its exclusive ownership to its customers (hereafter "Customers"). Bicycles are available for rent by Customers on a long or short term basis. A rental record is issued and signed by both the Information Centre and the Customer (hereafter the "Record").

Customers are not permitted to cede the rented items to a third person (except where a bicycle is rented by parent or guardian on behalf of their child). Customers are not permitted to sell the bike to a third person. Customers are not permitted to technically adjust the bicycle, except in the case of an accident or defect, if necessary. If having a rented bicycle serviced in a professional shop, Customers are obliged to declare this when returning the bicycle to the Information Centre, and must present a record of the repairs made.

When renting bicycle accessories, such as helmets, locks or other accessories, the accessories are considered, for the purpose of rental terms and conditions, the same as a bicycle.

Customers are required to present a valid form of identification (e.g. a driver's licence or a passport).

Bicycles can only be **rented by persons aged 18 years and above**.

**A deposit is required of CZK 1 500** per bicycle.

Deposits will be refunded to Customers upon return of the rented bicycles in due time and in good order. If a bicycle is not returned in due time and in good order, the Information Centre may use the deposit to pay any outstanding balance arisen from the breach of the rental conditions. The deposit may also be used as partial payment for failure to return a bicycle or bicycle accessories. **If a bicycle or bicycle accessories is not returned for any reason, the Customer agrees to pay to the Information Centre the following compensation:** CZK 8.500,- per bicycle, CZK 1.300,- per helmet, CZK 400,- per USB light, CZK 150,- per lock and CZK 200,- per pouch.

By agreeing to rent a bicycle and/or bicycle accessories, Customers accept all the associated risks and are liable for any damage caused by their operation of the bicycle. If the rented equipment is damaged, Customers are required to declare this to the Information Centre staff when returning the bicycle, and will be required to cover the cost of any repairs.

While renting a bicycle, Customers are required to make sure the bicycle is secured against theft and damage. If a bicycle is damaged by a third party, lost or **stolen**, Customers are obliged to inform the Information Centre and the **Police**.

Information Centre recommends the use of safety helmets and other accessories, all of which are available for rent without extra cost.

The Information Centre is responsible for the technical state and adjustments of bicycles before renting them out. By signing the Record, the customer confirms he/she was acquainted with the technical state of the bicycle.

The rented bicycles are considered as sporting equipment and comply with the road traffic regulations.

Rented bicycles must be returned at least 30 minutes prior to closing time. Failure to return a rented bicycle in due time entitles the Information Centre to charge the Customer an additional one-day rental payment.

By signing the Record, the Customer confirms that he/she is acquainted with the Bicycle rental terms and conditions and that he/she accepts them.
